ABOUT THE PROGRAM



- ❑ The Pradhan Mantri Kaushal Vikas Yojana 2023 (PMKVY) a skill training scheme of the Ministry of Skill Development and Entrepreneurship (MSDE), Government of India (GoI). It is being implemented by the National Skills Development Corporation (NSDC).
- ❑ It is under the Centrally Sanctioned and Centrally Managed component.
- ❑ Under this scheme, skill development training has to be provided to youth to build their capacity and make them employable.
- ❑ The Job roles/Trade to be selected for this scheme is identified by NSDC as per industry demand, selection of job roles has to be done from that list based on the available training infrastructure.
- ❑ Training Type-Both Non Residential and Residential.
- ❑ Under this program, all the activities has to be registered in Skill India Digital portal such as Candidate Registration, Batch creation, claim settlement, attendance, Centre registration as per NSDC guidelines.

ABOUT THE PROGRAM



- ❑ The attendance of the candidates is an integral part of this program, 70% attendance of the candidate has to be maintained in Aadhaar Enabled Biometric System Device (AEBAS) to seat for the Assessment, failing to maintain 70% attendance of the batch will lead to batch drop out.
- ❑ Maximum Batch intake size is 30 and Minimum is 10.
- ❑ The Qualification Pack has to be followed for pertaining the training.
- ❑ The Centre should be a Skill Management & Accreditation of Training Centre (SMART).
- ❑ The training cost will be estimated through Common Cost Norms for job role selected and the duration of the training.
- ❑ Last date of Batch Submission - **30th September 2023**
- ❑ **Project Duration** – Till 30th March 2024.

OBJECTIVE OF THE PROGRAM



As the country's largest skill certification scheme, PMKVY envisages realizing the vision by skilling India on a large scale with speed and high standards.

1.Enable and mobilize a large number of youth to take up industry designed quality skill training, become employable and earn their livelihood.

2. Increase productivity of the existing workforce, and align skill training with the actual needs of the State.

3.Create an ecosystem for the youth to make informed choices on the available skilling avenues.

4.Inclusion of new age courses for industry demand and expansion of the delivery network.

5. To develop the capacity of the youth to create income & explore entrepreneurship opportunities.

TRAINING COMPLIANCES



1. The Candidates should have Aadhaar Card mandatorily linked with active phone number.
2. The Training Centre should match with the SMART Accreditation Criteria.
3. The Center should have internet connection, AEBAS biometric ,power back up, dedicated lab and classroom, Fire Extinguisher, dustbin, Separate washroom for male and female, First Aid Kit equipment's as per QP and PMKVY branding.
4. The participants should be between age limit of 18-45 years.
5. The Candidates in the batch has to be present for initial 20 days for becoming eligible for 1st Claim/Tranche.
6. For submission of 2nd Claim/Tranche ,the Trainees should have 70% attendance to seat for the assessment and get certified. Only the certified candidates will be counted for 2nd claim.
7. The AEBAS biometric will not consider the late entries and early exit of the participant and will mark absent. The candidates has to absorb 70 % of the total training hours.

FINANCIALS



- ❖ Indian Institute of Entrepreneurship will hold 6 % share of the total project budget sanctioned as Project Management Unit.
- ❖ The State Government organization will hold 94% share of the total project budget sanctioned as training partner.
- ❖ The project amount will be sanctioned on 40% & 60 % term by NSDC. To claim for 40% ,the candidates in the batch has to be present regularly for first 20 days from batch start date and the 60 % claim will be released based on the total candidates certified in the batch.
- ❖ The payment will be released to the Training Partner based on NSDC terms and after IIE receives the fund from NSDC.
- ❖ The refund of an appropriate amount has to be made by the Training Partner for the payment released in 1st Tranche in case of drop out due to attendance fall and participants in the batch aren't assessed.
- ❖ The Reassessment cost has to be bared by the training centre.
- ❖ The payment will be calculated based on training hour and job role category as per Common Cost Norms.

ACTIONS TO BE TAKEN BY STATE GOVT. INSTITUTIONS



1. MoU signing for implementation of training and jobrole selection based on the available infrastructure.
2. Setting up of training centres as per NSDC guidelines & grading Matrix.
3. Providing final centre list to IIE for centre on boarding.
4. Awareness camp and advertisement has to be carried for mobilization completion.
5. Sharing Trainer details & documents with IIE for ToT registration.
6. Share Candidate data with IIE .
7. Call candidates to the training centre for counselling and then initiate registration and enrolment.
8. Share batch start date and timing list with IIE for all the training centre.
9. Use branding of PMKVY 2023 with TP logo(IIE) and centre details in the training centre.
10. Batch Commencement in the respective training centre and installation of biometric device.

ACTIONS TO BE TAKEN BY IIE



1. MoU Signing with the organization for implementing the program and target allocation..
2. Consultation for setting up centre and registration of training centre and completion of CAAF process on portal.
3. Getting centres Deemed ready and Scheme linking.
4. Registration of Trainers for ToT certification.
5. Provide branding pamphlet designs to centres.
6. Consultation in installation of AEBAS devices.
7. Provide QP, Model Curriculum and handbook soft copies for training.
8. Check the attendance regularly and make immediate intervention to avoid batch drop.

Instruction from NSDC For PMKVY 2023



To implement the PMKVY 2023, certain specific instruction is shared by National Skill Development Corporation to be followed and accordingly commence the training.

Project Deadline

NSDC have budgetary restrictions which may compel to close enrolment with immediate effect as soon as the available funds are committed therefore early enrollment is requested. **The last date showed in the portal is 30th Sep 2023.**

2

Boarding & Lodging

Specifically for this program, boarding & lodging facility is provided to the participants. The required infrastructure has to be available for accommodation by the Training partner.

Eligibility for Claim

For the first 20 days the candidates in the batch should be present regularly in training for becoming eligible for 1st claim. The entire batch should have 70 % attendance to seat for the assessment and certification for the remaining 60% claim .

Training Infrastructure

The training has to be done in government owned infrastructure. The equipment's in the centre should be as per the equipment list of NSDC and in running condition.
